Treasurer's Financial Summary

I am pleased to present the Annual Treasurers Report for 2019-2020. In the financial year to June 30, after a gross income of \$125,534 and expenses of \$98,808, the House had a net profit of \$26,726.

In what has been an unusual and tough year so far it is good to note that memberships have remained steady with a slight increase of \$124 and through much hard work by our Coordinator we received grants of \$34,000 comprised of JobKeeper, a Small Business Grant and a Cash Flow Boost which have helped to allay the reduction in income due to the restrictions and effects of COVID-19. These effects being that our Student Contributions reduced by \$14,512 and our COVID-19 Safety Measures cost to June 30 was \$745.

The full Financial Report as published was prepared by Cardell Assurance and Audit of Wonthaggi and an independent audit was completed successfully.

All things considered I'm pleased to report that the House finances are in a healthy state as at 30th June, 2020 and with continuing diligence are expected to remain so.


Getting to know the House users and volunteers that I meet in the House on Fridays, and at the other activities I attend has been the highpoint of the job. If only I could go to everything!

It has meant a lot of adaptation and new ways of working for us as well, and I would like to thank Lisa for being so supportive and flexible and also Andrea for always being just an email away when advice is needed.

I have endeavoured to use the House website and Facebook page to keep House members and friends up to date with what limited activities we have been able to run, and with links to activities that other organisations are running. I think I have just about shared every National, International and local 'day of' with our Facebook audience (now over 600 people). Some of them are very worthy and some just plain indulgent, like International Chocolate day. We also aim to make sure that all our members know about all the programs, support and help that various agencies are offering to Victorians and Bass Coast residents, through 'shares' on Facebook and on our dedicated 'Navigating COVID-19' webpage .

Please continue to follow us on Facebook, and read all about our programs on the website, from the Newsletter and in the South Gippsland Sentinel Times, and come back to the House as soon as you are able.

Coordinator's Report

It has been somewhat surprising to reflect on what feels like the year of COVID 19, which has dominated and challenged us all in our own individual ways and as a community. For many of us the separation of family, friends, income and networks has been difficult to navigate our way through and as many of you have mentioned, has created instability, anxiety, and a sense of loss in our lives.

The wonderful news is as a community, the positive outlook and empathy for each other has shone through. It has been amazing and humbling to observe our House users and members determination and creativity in maintaining and supporting each other through these very unpredictable times.

As an organization our doors were closed from March 2020. Initially, while this may have been daunting and unexpected, eventually we were able to determine our place and role as a community driven organization.

Checking in and advocating became our primary focus along with ensuring a COVID safe environment for all. We have had to modify and be creative to maintain our contractual obligations while still encouraging community connections at a time when physically we were unable to.

As the coordinator of the House, the year has thrown up many challenges personally and professionally. The support and guidance from the Committee of Management has been amazing and has strengthened us as a team and an organization. Our Office Support Worker Jill Vella has stepped up to the COVID-19 challenge and has gone above and beyond her role. It has been a privilege and exciting to work alongside her during the year.

Our Community

Welcome to Inverloch Morning Tea has been an ongoing partnership between CWA and the House. Once a month, newcomers are invited to enjoy a cuppa to get to know each other and learn more about Inverloch. It has attracted over 30 participants who have gone on to become House volunteers, CWA members and participants of other local groups. We thank the CWA for their ongoing support and look forward to more morning teas in the future.

South Gippsland Mental Illness Carer's Group meet once a month at various local locations including Inverloch Community House. We are proud of the relationship and trust we have developed over the years and look forward to supporting the group into the future.

The Soup Café continues to be a community favourite over the cooler months. Local groups and organisation's such as The Inverloch Angling Club, The Mens' Shed, The Chatty Crafters and the Walkie Talkies have all supported these events as hosts. It is their input and community spirit that keeps this event alive. Every year the event attracts newcomers who primarily come to "enjoy a bowl of soup and meet new people". Over 300 serves of soup have been enjoyed.

During COVID-19 the Chatty Crafters hosted a virtual Soup Café with the support of local bakery, Paul the Pieman. The simple matter of sharing food and making connections has many health and wellbeing benefits for these attending and volunteering at these events. The generosity and enthusiasms of all involved is a wonderful contribution to the community.

Thank you to Bass Coast Shire Council for their in kind support of Kitchen Hire.

Holiday Programs - Due to community demand, we delivered a range of art focused and creative workshops throughout the holiday periods which proved to be highly successful. Thank you to local artist Annette Marshall for sharing her skills and expertise.

Creating *Kokedama* and *Keshiki* plant workshops were also a great success with participants aged from 10–70 learning and creating alongside one another. Thank you to Alex Reardon for your wonderful demonstration.

As an ongoing partnership with *Inverloch Library*, Melbourne based organization Green Hat ran a *Summertime Planks Workshop*. Children and Parents enjoyed the creative and engineering challenge of working together in creating their own Plank dimensions. Over 50 participants attended.

Ongoing Groups such as the Walkie Talkies, Walk and Wag, Chatty Crafters, Pilates, Tai Chi, French, Italian, Bass Coast Writers, Inverloch Camera Club, Circle dancing and Line Dancing have been a staple at the Community House for many years. All in all, over 250 participants attend these groups on a weekly basis. Thank you to Geoff and Sue Haddock, Helen O'Brien, Cathy Bruton, Leah dal Pozzo, Carmel Cattach, Bernadette Stevens, Lucia Carotenuto, Villya Congreve, Bev Huntley, Gayle Marion and Kerri-Anne Pratt.

Due to the courage and persistence of tutors and key group contacts, many of the classes have been running online sessions throughout the COVID shutdown. Communications with these key contacts played a pivotal role in understanding the needs of and maintaining connections with our House users and individuals.

Hirers - There are 3 main rooms available for hire at the Community House. Between our regular hirers, local and Melbourne based organisations also utilize the rooms. Over the year we have seen an increase in demand for spaces needed for functions or meetings of outer region organisations. Some of those include: Victorian First Aid, Dive2U, Australian Hearing, Interact Australia, Thompson Bridge, Red Cross Patient Transport and Bird Life Australia.

Local representatives comprise of Inverloch Primary School, Bass Coast Shire Council, Inverloch Residential Aged Care Committee, Ian Symonds and Associates and personal hirers. As part of our operational plans, our Application for Room Hire form was reviewed and updated earlier on in the year to include the Emergency Evacuation Policy and procedures. It has since been updated once more, along with many other operational procedural documents to adhere to government requirements of the COVID-19 Safe Plan.

Our Partners and Stakeholders

Inverloch & Kongwak Primary School once again supported the House in the creation of the second part of our external Mural. Over 600 children have proudly contributed to the development of the mural over a 3 year period. The Mural is an outcome of the community's response to a previous survey. Inverloch people suggested that the House "needed its own identity" and the mural was a way of achieving this. Unfortunately, due to COVID restrictions, the Mural launch has been put on hold. We look forward to celebrating the launch in the hopefully not too far off future.

Neighborhood House Week takes place across Australia in May every year. A nationwide initiative celebrating the role of Neighborhood Houses and Centres in the community. “Loneliness, the solution is community” was the very timely theme for the year. The event was embraced as a Network Collective promoting the work and diversity across Gippsland. As a show of support to our Community House and the theme, Inverloch and Kongwak Primary School incorporated the initiative within the remote learning curriculum. It was an opportunity for children to reflect on loneliness and embrace the strength of themselves and their peers. Paper hearts were created and hung in windows to symbolize the sharing of hearts and connections within their neighborhood.

In August 2019, *West Gippsland Inverloch Library, Morwell Neighborhood House* and *Inverloch Community House* shared the Latrobe Valley Repair Café with Inverloch. The Café is an Initiative of Morwell Neighborhood House who are passionate about the environment and finding ways to reduce waste. By travelling around Gippsland, the café can educate and support similar cafes across Gippsland. Over 47 people visited the café during the day. Local repairers came on board to learn and share skills. Items repaired included soda streams, CD players, ornaments and more. As a House we value the opportunity to support such sustainable programs as these.

The community of Inverloch continue to support such campaigns as *Share The Dignity* and *It's In the Bag*. Inverloch Community House is a registered Drop off agency and has been for the last several years. Over 60 bags and many individual sanitary items were generously donated.

We continue to support *Inverloch Jazz Festival* by offering in kind Room hire over the long weekend in March. The House is used as a bit of musician's headquarters during the event. It is our pleasure to be able to support the Jazz community of Inverloch.

A positive outcome of the pandemic has been the development of stronger relationships with local providers and organizations. The House now currently meets with a number of service providers including *Bass Coast Shire Council* and *South Coast Primary Care Partnerships* on a regular basis. It provides us an opportunity to advocate on behalf of our community, provide feedback on initiatives and learn about valuable local service provider, COVID specific, community support.

I have also attended Neighbourhood Gippsland network meetings throughout the pandemic. These meetings previously took place in person on a quarterly basis but were ramped up due to the pandemic and the demand of Coordinators need of support and information. They have played a vital role in establishing an environment where coordinators feel free to voice concerns, seek advice from peers and advocate on behalf of their Communities across Gippsland.

Our Volunteers are the backbone to our organization. While some of our longstanding volunteers have spread their wings and flown the coup, friendly new staff have enthusiastically joined the team. This year we farewelled Sharon Morgan, a volunteer who has been with the House for 10 years. When I began my time as coordinator, Sharon was my go-to on office operations and information on our membership management systems. She played an integral role in training and educating myself, volunteers and new committee members. Other enduring, conscientious volunteers have also moved on. Pam McKay, Carol Young, Bev Krzyzanowski and Moragh Tyler have all made amazing contributions to the House. From managing rosters, office administration and general data base systems, these women ran a tight ship. We wish them all the best in their years of retirement. Thank you also to Anne

Howard and Marg Key. It has been a year in which we are forever grateful to have had these highly skilled and passionate volunteers on board.

Funding- Inverloch Community House were successful in securing 2 rounds of funding from the Victoria Government Business Support Fund. We were also successful in securing the Victorian Government Job Keeper payment in relation to the Coordinator employment status. The funding has enabled us to establish a COVID 19 safe environment for House users, staff and volunteers. Inverloch Community House receives 25 hours per week of recurrent annual funding from the Department of Health and Human Services via the Neighbourhood House Coordination Program. The organisation undertakes all compliance, accountability and outcome requirements for the funding received.

Our House

This year the 20 Neighborhood Houses across Gippsland contributed funds to engage Deloitte Access Economics to conduct a study and report on the Social impact of the work of Neighbourhood Houses. The report seeks to measure the social return of investment in the following key impact areas.

Health and wellbeing: Improved physical, mental and personal health and wellbeing

Connectedness and/or reduced social isolation: Built community relationships and improved social connectedness

Safety: Developed a safe and supportive community

Resilience and pride: Provided access to essential resources and crisis support, and developed community pride of place and empowerment


Independence and productivity: taught life skills.

NOTES TO THE FINANCIAL REPORT

FOR THE YEAR ENDED 30 JUNE 2020

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Reform Act (Vic) 2012* and the *Australian Charities and Not-for-profits Commission Act 2012*. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on a cash basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in this financial report.

Accounting Policies

(a) Income Tax

The association is exempt from income tax due to the nature of its activities.

(b) Plant and Equipment

Leasehold improvements are recorded at cost.

The carrying amount of plant and equipment is reviewed annually by the association to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the bases of the expected net cash flows which will be received from the asset's employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

Depreciation

Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements. The building is leased from the Bass Coast Shire Council. The current lease expired on 30 November 2019. Negotiations are continuing with Bass Coast Shire Council to renew the lease. It is expected the renewed lease will be based on similar terms to the current lease.

(c) Revenue

Revenue is recognised when the entity obtains control over the funds which is generally at the time of receipt.

Grant revenue is recognised in the income statement when the entity obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be reliably measured.

If conditions are attached to the grant which must be satisfied before it is eligible to receive the contribution, the recognition of the grant as revenue will be deferred until those conditions are satisfied.

(d) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of the acquisition of the asset or as part of the item of expense.

NOTE 4: COVID-19 PANDEMIC

In March 2020, a global pandemic for COVID-19 coronavirus was declared by the World Health Organisation. As a result, COVID-19 restrictions were introduced and the Australian Federal Government announced financial stimulus packages, including the ATO *Cash Flow Boost* and *Job Keeper*.

The association was entitled to an initial Cash Flow Boost of \$10,000 for the period from March to June 2020 and is therefore entitled to the second payment of \$10,000 to be paid in instalments from June 2020 to September 2020. The June 2020 instalment has been accrued as income at 30 June 2020, and the remaining \$5,000 will be received in September 2020.

The association was also entitled to participate in the JobKeeper scheme. The reimbursement for wages paid in June 2020 of \$3,000 has been accrued at 30 June 2020.

A \$10,000 grant was also received from the Victoria State Government.

The financial impact of COVID-19 to the 2019-20 financial year has been significant. In accordance with the Victorian State Government directive Inverloch Community House closed its doors to the public on 27 March 2020 and has remained closed to the date of this report. As a result, income generating operations have had to be shutdown, severely impacting the income and cash flow of the organisation. The overall income has declined by approximately 42% due to the loss of activity operations during this period. The receipt of government funding has provided cash flow to compensate for the loss of income.



We have reviewed the accompanying financial report, being a special purpose financial report, of Inverloch Community House Inc., which comprises the balance sheet as at 30 June 2020, the income and expenditure statement, the cash flow statement and the statement of changes in equity for the year then ended, notes comprising a summary of significant accounting policies and other explanatory information, and the statement by members of the committee.

Basis of Accounting and Restriction on Distribution

Without modifying our conclusion, we draw attention to Note 1 to the special purpose financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the association's financial reporting responsibilities under the *Australian Charities and Not-for-profits Commission Act 2012*. As a result, the special purpose financial report may not be suitable for another purpose.
